Falck Renewables S.p.A. informs to have purchased, between the 30 January 2017 and the 3 February 2017 included, n. 177,000 treasury shares at an average unit price of Euro 0.9549 per share, for a total equivalent value of Euro 169,021.8 pursuant to the authorization to the resolution passed by the shareholders on 16 January 2017.
