

## Falck Renewables: information about the purchase of own shares

*Milan, 04 June 2018.* Falck Renewables S.p.A. informs to have purchased, between 28 May 2018 and 01 June 2018 included, n. 37,000 treasury shares at an average unit price of Euro 1.9944 per share, for a total equivalent value of Euro 73,793.9 pursuant to the authorization passed by the Shareholders' Meeting on 16 January 2017.
