

Falck Renewables: information about the purchase of own shares

Milan, 18 June 2018. Falck Renewables S.p.A. informs to have purchased, between 11 June 2018 and 15 June 2018 included, n. 207,000 treasury shares at an average unit price of Euro 2.1498 per share, for a total equivalent value of Euro 445,002.8 pursuant to the authorization passed by the Shareholders' Meeting on 16 January 2017.
